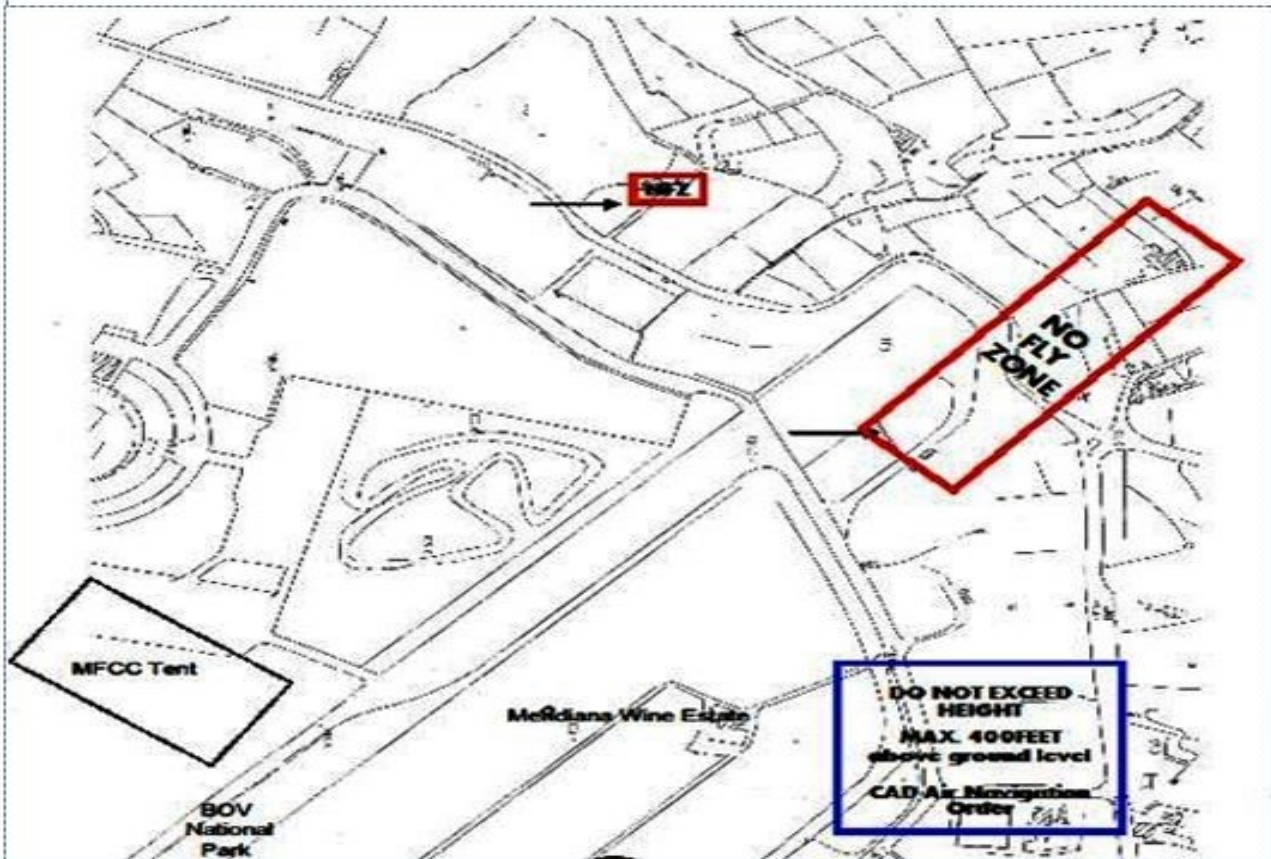

# NOTICE TO ALL PILOTS AND HELPERS

Respecting Fly Zones is not an option: It's mandatory!



No Fly Zones must be **AVOIDED** at all times! Should wind direction or sun position cause you concern play safe and don't fly. There are no morning, afternoon or evening or model exceptions. Self regulation is the key if we want to keep our site. All flyers are expected to fly responsibly. Have a 'look out caller' backing you especially with high performance models. It is your responsibility as a pilot to MAKE ALLOWANCES AND PLAN YOUR FLIGHT PATH according to the **SIZE, POWER, SPEED** of your model and **WEATHER CONDITIONS**. Leave a clear safe margin especially when approaching lower and closer to No Fly zones. Safety is our number one priority.

**ALL CRASHES OUTSIDE OUR FLYING SITE BOUNDARY**

**MUST BE REPORTED WITHIN 24 HOURS TO THE COMMITTEE**
